**FROM PHILADELPHIA, PA:** Take Rt. 42 South to Rt. 55 to Exit 39 A (Malaga/Rt. 40). At next light (WVa WVa on corner) make a left. Follow to Route 40 E and make a right at the traffic light. Travel 50 yards and make left onto Dutch Mill Rd. Travel 5 miles on Dutch Mill Rd. White Oaks is on the left.

**FROM DELAWARE MEMORIAL BRIDGE:** Take the Delaware Memorial Bridge to Rt. 40 E (Atlantic City Exit). Take Rt. 40 E thru Woodstown, then thru Elmer. Follow over Rt. 55 overpass and make a left at 1st traffic light (WVa WVa on the corner). Then make a right onto Route 40 E at next light. Travel 50 yards and make a left onto Dutch Mill Road. Travel 5 miles on Dutch Mill Rd. and White Oaks is on the left.

**FROM ATLANTIC CITY:** Take Rt. 322/Black Horse Pike West. Go past Hamilton Mall about 24 miles and make a left onto Piney Hollow Road (jug handle). Travel 2 miles and make a right onto Dutch Mill Road. Go down 2 miles and White Oaks is on the right.

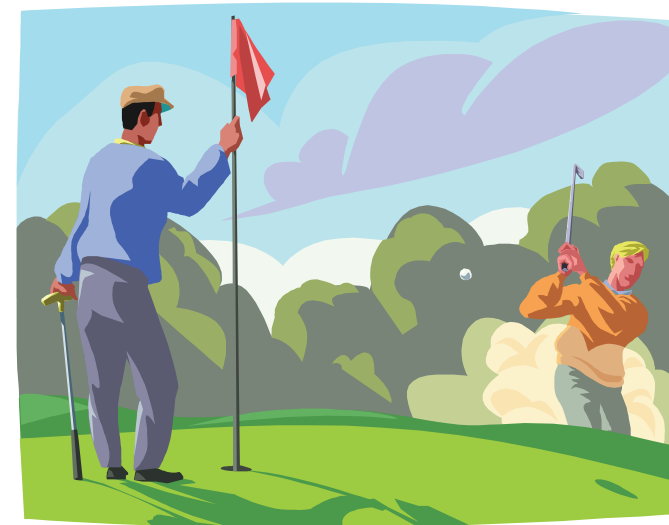
